Fees for services paid by you

Initial Consultation: Between \$0 - \$550 (including GST).

As financial advice is tailored to each client's unique needs, the cost of developing your strategy, preparing your financial plan, implementing recommendations, and providing ongoing support will vary. Fees are determined based on the scope and complexity of the advice provided. We will outline the applicable fees for your specific circumstances and ensure full transparency before you proceed with our advice.

Initial Advice & Implementation: Starts at \$4,400 (including GST).

Ongoing Advice: Starts at \$350 per month (including GST).

Other Costs: On application. Additional services provided outside those mentioned above may attract a minimum fee of \$350 (including GST) per hour. Additional charges after the first hour will be at a rate of \$350 (including GST) or part thereof.

All fee for services will be agreed upon prior to providing advice or implementing any services.

Commission

Insurance products

The commission is factored into the annual premium and may range as follows:

- From 0% to 66% (including GST) of the initial premium.
- From 0% to 22% per annum (including GST) of the renewal premium.
